Background

- Elders aged 65 years or older: 17.4% of the total population in 2018
- Life expectancy at birth:
- Males: 82
- Females: 88

Aging policy

Aging in place as the core

- It assigns top priority to encouraging elders to stay at home.
- To prevent unnecessary or misplaced institutionalisation

Institutional care as backup

• To provide a wide variety of residential care services (RCSs)

Continuum of care

- To accommodate the varying degrees of needs of elders who are unable to take care of themselves at home.
- To encourage elders to stay at the same residential care homes for the elderly (RCHEs), even if their health conditions deteriorate.

Community care and support services

Centre-based services

 e.g. meal and laundry services, drop-in service and social and recreational activities


Home-based services

• e.g. personal care, rehabilitation exercises, day care services, cooking and meal delivery services, transportation and attendant services.

Pilot Scheme on Community Care Service Voucher for the Elderly (CCSV)

- a money-follows-the-user approach
- The voucher holder must make a co-payment.
- The elders can choose a service provider and the type of service.
- 3 phases


Insufficient supply of subsidized CCS

Singapore	2.9%
China	1.7%

The utilisation rate of CCS

Regions	the utilisation rate of CCS
Hong Kong	0.8%
Japan	5.5%
Taiwan	1%
China (i.e. Shenzhen)	19%

Structural and cultural barriers of aging in place


Structural barriers

- The funding mode of LTC (the underdeveloped private market of CCS vs. a mixed economy of care of RCS)
- The imbalanced budget allocation to RCS and CCS

The decline in the traditional Chinese values of filial piety

The imbalanced budget allocation to RCS and CCS




A voucher system

- It's a 'money-follows-the-user' approach, and the co-payment scheme.
- The SWD will send invitation letters to anyone on the central waiting list for either CCS or residential care service (RCS).
- 3 phases:
- 2013 to 2017 (1,000 vouchers)
- 2016 to 2020 (7,000 vouchers)
- From October 2020 onward (8,000 vouchers)







- : Structural barrier: will be/have been allocated with subsidised CCS or subsidised/ private RCS
- Natural turnover (death, taken care of by family members or domestic helpers, hospitalised, out of town)
- No suitable service providers/ service packages
